Maxine likes to joke that her first family had to walk by her washing machine for their meetings. What a long way The Adoption Agency, now Adoptions From The Heart has come. Starting the first year with 16 placements and fast forward 30 years, 8 offices and 6 states to now more than 6,500 families created by AFTH.

# FMLA & Adoption Leave: Knowing Your Rights



Adoptive parents often find they faced with are questions that other new parents might not even have to contemplate such as "Am I eligible for leave to care for my child?" It is important for adoptive parents to be aware of

their rights so they can consider all their options when deciding to take leave. The Federal Family and Medical Leave Act (FMLA) extends it's coverage to all new families including adoptive and foster parents. However, it is important to note that new employees and those of smaller companies might not be protected under the act and others who are eligible for FMLA might not be able to make "leave without pay" work for their family.

#### What is the Family and Medical Leave Act (FMLA)?

FMLA was created to help employees' balance work and family life, by protecting employees' ability to take a reasonable amount of unpaid leave for certain family and medical reasons. Falling under this category is adoption maternity/paternity leave of adoptive and foster parents. According to the United States Department of Labor, FMLA "provides certain employees with up to 12 weeks of unpaid, job-protected leave per year. The FMLA also requires that the employee's health benefits be maintained during the leave." FMLA applies to private sector businesses with at least 50 employees, to all state and local governments, and to all public and private school employees.

### FMLA Eligibility Requirements

The U.S. Department of Labor states "Employees are eligible for leave if they have worked for their employer at least 12 months, at least 1,250 hours over the past 12 months, and work at a location where the company employs 50 or more employees within 75 miles."

Employees not eligible for FMLA may still be able to work with their specific employer to come to an agreement about leave. It is important to note that depending upon where you live, your state laws may be more beneficial than FMLA (such as requiring employers to offer a certain amount of <u>paid</u> leave).

### How does FMLA apply to adoptive families?

Becoming an adoptive family takes a lot of planning. In regards to the FMLA, many families will need time off from work because they may need to plan to stay in the state where their child was born, which is on average 7 to 10 business days to comply with the Interstate Compact on the Placement of Children (ICPC). For all types of adoption, eligible employees may begin their leave before a child comes home as long as the absence is necessary to the adoption process. An employer may ask for proof that a requested leave qualifies under FMLA and in that case a letter from your agency or attorney should be all they need.

#### Are Foster Parents Eligible?

Yes, foster parents are covered regardless of the age of the child, however the state or court must be involved for the placement to count under FMLA, so kinship adoptions do not count.

#### Can father's qualify for leave as well?

Yes, unlike maternity leave FMLA applies equally to all parents.

### When Can FMLA be Used?

The 12 weeks of unpaid leave may be taken at any point in time during the 12 months following the birth or placement of a child. This means that if both parents are eligible for FMLA, they could stagger their leave to have a total of 24 weeks back to back. Employers are able, but not required to allow employers to take the 12 weeks intermittently (for example taking half days for 24 weeks).

### What if We Both Work for the Same Company?

If both parents work for the same employer, the employer is able to limit the leave to a combined 12 weeks unless the child has a serious medical condition, in which case then each parent is entitled to 12 weeks. Meaning an employer, in the case of a healthy child, could grant both parents leave however the time off combined can be limited to 12 weeks total instead of each parent being granted 12 weeks.)

#### Is My Job Protected While I'm on Leave?

FMLA makes it illegal for employees to be penalized for taking leave and requires that employees return to work at the same level of pay and benefits as when they left. Additionally, if an employee participates in the company's group health insurance plan, the employee will remain covered during their FMLA leave.

#### Can I Stack My Accrued Time Off and FMLA?

FMLA allows employees to substitute accrued (sick/ vacation/personal) paid time off for a corresponding portion of their leave. Employers do have the option of requiring employees to use their accrued time as part of their FMLA leave to prevent employees from using FMLA's 12 weeks in addition to their accrued time off.

You may be surprised to know that depending where you live, you may have access to even better benefits that the FMLA offers. More and more states are now requiring smaller companies typically immune from FMLA to offer some level of family leave. Some states even expand on FMLA's minimum standards and offer a portion of paid time off or even more than 12 weeks. It is important to educate yourself on the laws so that you know what you are entitled to as an adoptive parent. # Preparing for a Disruption During the Revocation Period

I do not want to feel as though I'm just running down the clock during those 30 days. I'd like to know that I was chosen to be our child's parents...

We are just days away from going "in the books." What an exciting step! It also marks the last part of the adoption process over which we have control. Now the real wait begins.

Throughout our ed classes and home study process, the topic of disruptions has

been discussed to help prepare us for the possibility. A disruption is the term used to describe when a birth parent changes his or her mind about placing during their revocation period, after the child has been placed in the adoptive parents' home. Our agency cites a low disruption percentage rate, but, however rare, I doubt that statistic matters to those experiencing it.

Knowing we will be matched with an expectant mother from Pennsylvania, Connecticut, New York, New Jersey, Delaware, or Virginia, our agency thoroughly educated us on these states' adoption laws. Of these states, Pennsylvania has the longest revocation period, 30 days, and New Jersey doesn't have any revocation period once the relinquishment paperwork is signed.

When speaking about the revocation period as an adoption professional, I often find that people are surprised there is such a timeframe when birth parents are able to change their minds after placement. It is so important to remember this is one of the most difficult decisions anyone could ever make.

I once read a letter a mother wrote to the prospective adoptive parents who faced a disruption after she'd decided to parent. She explained that nothing they did or said caused her to change her mind and, most importantly, she didn't change her mind to cause them pain. Just as any parent would, she was doing her best to make the choice for her baby.

The revocation period will make certain of one of two things: 1) That she feels an adoption plan is the right choice, even through the grief, sadness, and heartbreak she will be feeling. Jill, a birth mother blogger of The Happiest Sad wrote: "Never doubt, not for a second, that you are loved. There is no one else in the world for whom I'd break my own heart. Only you." Or 2) That she decides that placing her baby for adoption was a mistake and that she will parent.

Because of the magnitude of this life-long decision, I believe there needs to be a revocation period. A woman who has just had a baby and signed the legal adoption papers needs and deserves time to deeply contemplate the decision she had made, and to change her mind, if she feels that's right. Others may not agree, and some adoption professionals and parents talking about it being "easier" on the adopting parents when there is a very short revocation period, or no revocation period at all. But as an adoptive parent, especially one seeking an open adoption, I do not want to feel as though I'm just running down the clock during those 30 days. I'd like to know that I was chosen to be our child's parents, and that his or her birth mother didn't decide she had made the wrong choice on day 31.

No matter what decision is made, there will be heartbreak, because adoption is not one-sided. If we experience a disruption, whether after two hours or 29 days, I know I will feel heartbreak. And if they decide their decision to place was right, the birth parents will nevertheless surely feel heartbreak.

I can honestly say that, when we are lucky enough to get "the call," knowing there is a revocation period will not cause me to hold back the love I know I will feel for the child placed in our arms. However, I will remind myself that we have been asked to be the temporary caretakers of a child who may indeed come into our family while his or her parents are ensuring they are making the best and final decision, and we will think of them with compassion and respect. And if the 30 days pass and they don't revoke their consent, we will rejoice in our own family's togetherness while remembering that there is a loss not only for our child's birth parents, but for our child. We will remember that adoption causes a ripple effect and that our experience is only one side.

dealing with moving to a foster home or to a new adoptive home from their biological home, there can be excitement and sadness. This book can help facilitate the conversation on having these conflicting feelings and that being perfectly normal. There are nice illustrations and easy to understand text.

# AFTH Program Updates

**DOMESTIC PROGRAMS** - We hope your family was able to attend one of the AFTH annual picnics! The picnics are always a wonderful time for families to come together. It is nice to see new families who are just starting the adoption process, families who just received placements as well as families who have been coming for years. Our staff was so happy to be joined by so many other families to celebrate adoption. *See picnic recaps in the newsletter insert*. The Fort Washington Picnic had to be moved to a new day and date for next year due to park closures. The picnic will be on **SATURDAY, June 18, 2016.** 

In the 2014-2015 fiscal year, Adoptions From The Heart has placed a total of 135 infants in adoptive homes. Not counted in these statistics were 3 special needs placements, 2 sets of twins (counted as 1 placement for stat purposes), and 5 identified placements. Our placement rate remains high compared to number of waiting families. The majority of families currently in the books (67%) are waiting less than 1 year. Families open to children of African-American heritage are seeing significantly shorter wait times with the majority of families (59%) currently waiting 6 months or less and 41% waiting less than 3 months. With an average of 25-30 waiting families open to African-American children and the fact that we have already placed 26 children in the past 6 months, the agency is seeing these families having relatively short waits. Additionally, 43% of our birthmothers report no drug or alcohol use and our emergency placements have increased over the past year as the fiscal year ended with a 58% emergency placement rate.

AFTH is proud to be celebrating its 30th anniversary this year and we are hosting a special celebration in honor of our exciting milestone and we want you to be a part of it. See event details on the front page.

**To All Placed Families:** AFTH continues to see an increase in the need for financial assistance to aid the pregnant women we are counseling. This year's Annual Appeal (*page 3*) calls to AFTH placed families, friends, and adoption supporters to consider making a donation to either the Birthmother Fund or Birthparent Scholarship Fund. Every penny donated to the Birthmother Fund aids pregnant women working with AFTH who are struggling to provide for their basic needs such as food, clothing, and shelter. And the newly established Scholarship Fund, which has already awarded two scholarships, was created to offer financial support to birthparents who are focusing on continuing their education to make better lives for themselves. All donations, no matter what amount, are graciously accepted and are tax deductible.

**NEW MINIMUM OPENNESS POLICY** - AFTH has added a new minimum requirement that all prospective adoptive families will need to be open to in our program. In addition to sending pictures and letters once a month for the first six months and then once a year after that, AFTH is now requiring all families who applied to the program after June 15, 2015 to be open to a minimum of 1 visit a year as well. This new policy reflects the agency's focus on the benefits of open adoption for all those in the adoption triad.

AFTH has many great classes lined up for our Fall Ed Series beginning in September and running through the end of fall. Classes include: Effects of Prenatal Exposure to Drugs/Alcohol, Birthparent Panel, Effects of Parental Behavior Health Disorders and Talking to Your Child about Adoption. Our classes tend to fill up fast so if you see a class you want to attend, don't wait until the fall to book your seats. *See class details in the newsletter insert*.

In addition to the Ed Series, AFTH offices continue to hold regular childcare classes for prospective adoptive parents. An August class is being held in Wynnewood, September classes in Delaware and Central PA, and October classes in Cherry Hill and Allentown. To sign up for the classes, visit the online calendar of events.

Local AFTH Offices host support groups for waiting families as well as birthparents and we hope that you will consider joining us. It is a great time to connect with other families and to receive updates from your social worker regarding the Program. You can also stay connected with AFTH by following us on our different social media sites: Facebook, Twitter, Etc.

AFTH offers professional training on adoption and options counseling to our local hospitals, clinics, and

agencies that work with women and families. AFTH has been focusing on building better awareness around adoption and the options women have when faced with an unplanned pregnancy. Additionally there are a number of conferences that AFTH staff will be participating in this fall (see page 5) and we look forward to meeting all the new prospective adoptive parents who will be attending.



HEARTBEATS - We welcome anyone wanting to learn more about AFTH's Embryo Support Services. The program is an excellent option for families in which a woman is able to carry an embryo donated by another family. # **Recent Legislation**



ADOPTION TAX CREDIT: Senators Casey (D-PA) and Blunt (R-MO) introduced the Adoption Tax Credit Refundability Act of 2015 (S950) on April 15 which would make the current adoption tax credit (ATC) fully refundable. Nearly one-half of families adopting from foster care are at or below 200 percent of the federal poverty level and many have tax burdens so low that they cannot benefit unless the ATC is refundable.

AMENDMENT TO CHILD CITIZENSHIP ACT OF 2000: In response to the proposed deportation of Adam Crasper, Korean adoptee whose American adoptive parents never applied for citizenship for him, Senator Jeff Merkley (D-OR) and Senator Amy Klobuchar (D-MN) have agreed to co-sponsor an amendment to the Child Citizenship Act of 2000. The amendment would grant automatic U.S. citizenship to international adoptees, including retroactive citizenship to those who were already 18 when the Act first went into effect. "For the U.S. to deport adoptees to a country they likely do not speak the language, do not understand the culture, and do not have any connections or resources is a reprehensible and shameful act," said March. "If members of Congress do not support this amendment, it is equivalent to objecting to the fundamental purpose and values of adoption."

PROTECTING ADOPTED CHILDREN ACT: On April 28, Rep. Langevin (D-RI) introduced the Protecting Adopted Children Act (HR2068) "to ensure the safety and well-being of adopted children." Rep. Langevin said it is "a response to the many problems and potential dangers associated with the term 'rehoming" adoptive children. Families involved in this underground practice are connecting online and making dubious or outright illegal arrangements to give away their children to strangers, often with forged or fake documentation." The bill would "provide for pre- and post-adoptive counseling and help to fund treatments specialized for adopted children, including psychiatric residential services, outpatient mental health services, social skills training, intensive inhome supervision services, recreational therapy, suicide prevention and substance abuse treatment." Services such as peer-to-peer mentoring, support groups, and a 24-hour hotline would be available for adoptive parents. The act would add addressing illegal child transfers to the Internet Crimes Against Children Task Force training. The bill was referred to the Committee on Ways and Means and Committees on Energy and Commerce and the Judiciary. It has six Democratic and one Republican cosponsors and currently no companion bill in the Senate.

OHIO: On March 20th, 2015, Ohio became the ninth state to open birth certificates to adopted adults from a previously closed period. Adults adopted between 1964 and 1996 may now gain access to their original birth certificates. Adults whose adoptions were finalized in Ohio before 1964 already had access. Those adopted on or after Sept. 18, 1996, can receive their files unless their birthparent asks to be excluded.



# International Adoption News

AFTH prides itself on keeping abreast of news regarding inter-country adoption. The agency continues to provide Home Studies, Education, Post-Adoption/Placement Reports and Services, and other assistance in support of international adoptions, despite no longer having placement programs in foreign countries. AFTH collaborates with many agencies across the United States

that do provide inter-country adoption placement services. Contact your local AFTH office to see how we can help you with your adoption process, including referring you to one of these partner agencies. #### CHINA

As of this writing Chinese adoptions continue to be extremely slow. In late May, the CCCWA had officially completed three Log In Dates in late December since January. They were 12/26, 27 and 28 of 2006. Two of our transferred families to Carolina Adoption Services received referrals. One has just returned home and the other will travel in September.

#### BRAZIL

Brazil's Central Adoption Authority has authorized a limited number of Hague accredited adoption service providers to provide adoption services in Brazil. The following agencies have been approved to work in the country: Lutheran Social Services of Minnesota, Lifeline Children's Services, Hand in Hand International Adoptions, and Across the World Adoptions.

#### DEMOCRATIC REPUBLIC OF CONGO

The judicial advisor at DRC's interior ministry announced that 71 of nearly 1,000 ongoing individual adoptions will be completed with families across 5 countries including the USA and Belgium. Adoptions there were suspended in 2013. The Department of State strongly recommends against adopting from the DRC.

#### GHANA

On May 21, 2015 in Geneva Ghana's Cabinet has approved the ratification of the 1993 Hague Convention on Protection of Children in Respect of Inter-Country Adoption. The new procedures for adoption are being finalized by their Attorney General's Department.

### KATHMANDU

In order to curb child trafficking in the aftermath of the April 25th earthquake, the Ministry of Women, Children and Social Welfare has banned child adoption. The ban applies to both international and local child adoption. "Children are at high risk of becoming trafficking victims during disaster as they can be lured by traffickers with the prospect of comfortable life and better education. So we have banned child adoption for now," said the joint secretary at the ministry.

#### SOUTH KOREA

At the peak of South Korea's international adoption placements in the 1980s, 24 babies left their birth country every day to be adopted by foreigners, three quarters of whom were Americans. Today, however, the numbers of unwanted South Korean infants continues to rise but the ability to place them for adoption has fallen drastically. Revisions to South Korea's adoption law in 2012 has limited even more the already low numbers of available infants to be adopted internationally. Some South Korean-born adoptees' lobby groups have encouraged Korean domestic adoption even though members of the group were raised by families abroad. They campaign against international adoptions from South Korea and for the right of adoptees to find their birth parents. An unintended consequence of the new restrictions has made it more difficult for domestic in-country families to adopt too. Taboos against adoption remain stubborn in South Korea.
