"Victoria called me yesterday in shock. She was so thankful to have received the gift cards


for her three children at home and couldn't thank the agency enough. I'm really happy for them as they have been through quite a lot this year."

Adoption 101



Begining a new year often brings the feeling of a new start. If this is the year you have decided to begin your adoption journey, here are some pointers to get you started.

- ♥ One Size Does Not Fit All What worked for your friends or relatives may not be right for you. There are many variables that determine which option is the best fit for your family. Domestic adoptions from the U.S. offer families the opportunity to know their child's medical background, meet their child's birth family, and the possibility of adopting an infant. International adoptions offer more predictable time frames, no chance of disruption, and the opportunity to bring an older child from another culture into your lives.
- ♥ Do Your Homework There are few decisions in your life as important as this one, so turn to the experts for help. Attend free adoption information meetings or webinars, read books, ask questions.
- ♥ Separate Fact From Fiction Myths surrounding all aspects of both domestic and international adoption are plentiful. Be open-minded, ask questions, and base your decision on the facts.
- ♥ Adoption Professionals Are Not Created Equal When choosing an agency, consider years in business, the number of yearly placements, full list of services provided, counseling and treatment for expecting parents, and ongoing support services. Be sure that your agency is state licensed and non-profit, also Hague accredited if you choose international adoption.

If you choose to use an attorney, make sure they understand the adoption laws of the state you reside in and the states that the potential birth parents live. It is highly recommended to use an attorney who is part

of the American Academy of Adoption Attorneys. Ask what support and counseling the potential birth parents will receive before and after placement. Often attorney's can partner with agencies to provide these services.

If you are considering an Adoption Facilitator, first find out if this is legal in your state. Facilitators are usually small organizations with one or two staff members who often have no counseling background. Most adoption facilitators only provide a matching service and once a match is made, the facilitator passes it on to another professional and remove themselves from the rest of the process. They act as middle men who charge families extra money to facilitate their adoption.

- ▼ Taking The Fear Out Of The Homestudy You don't have to be perfect, you don't have to own a home or make hundreds of thousands of dollars. A home study is a written evaluation regarding the suitability of your family to become adoptive parents. There is also an education component to help you better understand the unique aspects of creating a family through adoption.
- ▼ Know The Numbers Understand the fee schedule and make sure all the costs are listed to avoid any surprises down the line. Steer clear of adoption professionals who aren't forthcoming about fees. Don't let fear of expenses keep you from adopting get the facts, check out tax credits, employer reimbursements, grants, low interest loans, military subsidies and creative financing. Also be sure to ask when the fees are deemed earned and what would happen in the event of a disruption.
- ♥ Be flexible The adoption process can be unpredictable. It's important to be flexible and not hold yourself to preconceived notions you had at the beginning.
- ♥ Build A Support Team After all the paperwork is complete, classes taken and profile created, it's time to wait. Many families find this the most stressful part of the adoption journey. Join a support group either online or in person. Surround yourself with family and friends who can support you during this emotional time. Never be afraid to reach out and call your social worker. They are there to support you through this process.
- ▼ You Can Create a Family Through Adoption Be patient, and persistent and it will happen. It may take time, but if you are persistent, it will happen.

When I found out that I was pregnant, I felt as though my dreams of becoming a nurse were out of the question. After placing my child through Adoptions From The Heart, I realized just how important it is to get an education. AFTH helped me get there. I am now an RN, at a children's hospital, doing what I love.

After seeing birthparents determined to reach their educational goal doing everything they can to make it work yet still struggling to find ways to financially make their dream come true. AFTH established the Birthparent Scholarship Fund as a way to help them reach their next step. The Fund was established in the summer of 2014 and after six months of raising money, the very first scholarships were awarded in January 2015. Since then, six additional scholarships have been awarded. The scholarships are not limited to birthparents who have placed children through AFTH. Any birthparents who have placed children after 1985 are eligible to apply. Once awarded a scholarship, the winner is able to re-apply for the scholarship for up to eight semesters.

Heather, an AFTH birthmother, said it best when she spoke to the crowd at our 30th Anniversary event in October. She shared her personal adoption story and then left us all with this call to action: "We, as birthmothers, also want to prove to you that we can make it, that we're good and kind and smart. Remind us of that; help us heal by helping ourselves. Please give whatever it is you can to the Birth Parent Scholarship Fund, it will provide us with the very thing we try to instill in our children. Show us that you support us in everything we do and set out to accomplish. We want you to be proud of us too."


families remarked on how much they loved the 2016 Adoptions From The Heart Calendar!



Recent Legislation



INTERNATIONALLY ADOPTED CHILDREN MAY BE AT RISK

FOR DEPORTATION - Thousands of foreign-born adoptees raised in the U.S. are vulnerable to deportation as adults due to a failure of immigration law and inaction by their adoptive parents. Without U.S. citizenship, they can be tossed out of the only country they've ever really known. Prior to the Child Citizenship Act of 2000, foreign-born children adopted by U.S. citizens entered the country as permanent residents, according to attorney Dan Berger, a member of the American Immigration Lawyers Association. After the typically lengthy and expensive process

of adopting children from overseas, Berger said, many parents would "take a breath" and not apply for citizenship for their child. Foreign-born adoptees who have green cards can work, are eligible for a driver's license, can vote in state and local elections, and even qualify for Social Security benefits and student loans **however** unlike citizens, they can be deported, even for nonviolent misdeeds.

Time will eventually solve this problem. The 2000 bipartisan law granted automatic citizenship to an estimated 75,000 adopted children then under age 18. The law applied to future adoptees as well. But it was not retroactive. Those who were already over 18 as of Feb. 27, 2001, were left off the welcome wagon. Sen. Amy Klobuchar (D-Minn.) is trying to help those who were left out of the 2000 law stay in the country. In November, she introduced an amendment to make the 2000 law retroactive.

DESPITE SAME-SEX MARRIAGE RULING, GAY ADOPTION RIGHTS UNCERTAIN IN SOME

STATES - While same-sex couples have long been able to adopt from private, gay-friendly adoption agencies, adopting children from the foster care system has proved more difficult in some states.

The U.S. Supreme Court decision in June that made same-sex marriage legal nationwide is changing that, but not everywhere—particularly in states with laws that limit joint adoption to a husband and wife. Some states have taken up legislation that would allow taxpayer-funded contractors that oversee state adoptions to refuse to let gay or lesbian individuals adopt children if it conflicts with the organization's religious beliefs. Mississippi is the only state that has a law that specifically bars gay couples from adopting foster children, and Julia Bryan, spokeswoman for the state Department of Human Services, said the law will be followed unless the legislature makes any changes when it reconvenes in January.

Although the court decision is leading to changes in some states, others are creating new roadblocks to gay adoption. Some states are creating laws that allows groups that contract with the state to oversee adoptions to decline service to any person or couple that conflicts with their "sincerely held religious beliefs."



No SSN For Child... What To Do For Taxes?

Some families who have adopted domestically in 2015 have not finalized before the end of the year which means their child has not officially been issued a Social Security number.

The IRS can issue families in these situations an Adoption Taxpayer Identification Number (ATIN) which is a temporary nine-digit number for a child who does not have a SSN in time to file taxes. ATIN numbers can be requested through the form W-7A which can be downloaded online at www.irs.gov. Documentation describing how your child was placed with your family will need to accompany the form. It can take up to eight weeks to receive an ATIN and it is valid for two years and can be used to claim dependency on tax documents.

Consult with your tax preparer if you have additional questions about requesting an ATIN for your child or about the tax credit.

Book Reviews



How Open Should My God and Jetfire: Confessions of a Birth Adoption Be? Levels of Openess in Adoption by Russel Elkins - This 50 page book is packed with a lot of really important information. Elkins, an adoptive father, has a very open adoption with both of his children's birth parents. These relationship form in

different ways and change over time. Elkins is open about his mistakes in hopes that other adoptive parents can learn from them to better navigate forming new relationships with birth parents.

The gems in this book touch on social media, extended family, and the importance of communication. It also highlights why the first year is typically much more stressful than initially anticipated. Becoming new parents all while juggling a new relationship with your child's birth parents, lack of sleep, fear of disruption, and the continued involvement of social workers until finalization can put strain on what is already a very emotional time

Another important section in his book covers the time in the hospital. It is important to respect the birth parents time with the child in the hospital. Remember that although you will be extremely excited, this time in the hospital needs to belong to the birthparents. It isn't your time to start parenting. You may have a lifetime to do that and they have the very short period of time spent in the hospital with their baby.

This book can be read in an hour but it is one you may want to keep around as a reference as you journey into the world of open adoption. He has some really great ideas and some really profound insight which will give adoptive parents and prospective adoptive parents quick a bit of food for thought.

Throughout the book, Elkins references his other books which are also excellent reads

wrenching account of Seek placing her son for adoption. It is an honestly raw and soul baring account of placing a child for adoption. The mix of emotions, grief, anger, happiness, relief, frustration, and loss are laid bare for the reader. It reiterates that adoption is a lifelong process for everyone involved and doesn't end after placement.

Seek and her boyfriend compose a list of 100 questions and interview couples to find the "right" family. She has an open adoption with her son's adoptive family, she meets with them, talks to them and exchanges correspondence.

After several hours of labor, Seek ultimately starts having second thoughts. She winds up taking her son home and parenting him for about a month before she then decides to relinquish her rights. The book illustrates the power-shift that occurs after placement as it shifts to the adoptive parents. Seek felt powerless and lost with her emotions. It is so important for adoptive parents to grasp an understanding of the pain and loss that is experienced in adoption.

AFTH Program Updates



DOMESTIC PROGRAMS - AFTH hopes that you had a wonderful start to 2016 and wishes everyone an incredible year!

We had a wonderful turnout for our office holiday parties and we are looking forward to seeing all the families again at our summer picnics. It is important to note that for 2016, the Fort Washington Picnic has had to shift weeks due to the park shutting down the Flourtown pavilion for several weekends in June. The picnic will be held at the same time and place on SATURDAY (note the change from the typical Sunday), June 18th.

We are so happy to see how many new families and open adoption connections were made through our agency in 2015. In December alone, we had 15 families selected, 11 of those were for emergency placements. Even though the AFTH offices were closed for a week and a half for the holidays, several of our social workers were still busy with placements. Hospital social workers and nurses know they can count on AFTH to always be available even over holidays which is why the agency often sees several emergency placements during the holiday break.

As we closed out 2015, we saw an all time high emergency placement rate. 59% of all of our placements in 2015 were emergencies. So if you are currently a waiting adoptive parent, know that the chances of receiving the call and having less than 24 hours before you need to be at the hospital is likely.

This past year, AFTH placed 145 children into adoptive parent homes through open adoption.

Social workers are continuing their extensive outreach to spread awareness about AFTH's free services to women considering adoption. In 2015, AFTH social workers connected with over 1,600 referral sources to provide information and to offer trainings for staff.

In addition to offering trainings for professionals, AFTH offers specially designed classes for adoptive parents. Twice a year, AFTH hosts an Ed Series with various classes held in the different offices that are specifically designed for adoptive parents. The most popular classes have been those that help prospective adoptive parents complete their key such as the Prenatal Effects of Drugs and Alcohol. Many of the families who have attended have said how much the information they gained during the class helped them to better decide how to complete their key. Our class line up for the spring also includes, infant care classes, impacts of parental behavior and mental health on children, post adoption advice, the art of college cost planning and even a pizza party for adoptees! The classes often fill up quickly, so please be sure to register in the next few weeks to reserve your spot. For class details, see the newsletter insert.

A Letter from Executive Director Maxine Chalker



To say I'm proud that Adoptions From The Heart is now going into our 31st year of service is an understatement. First named The Adoption Agency, it began in the basement of my home and I laugh now when I retell the story of how my first adoptive couple walked by my washer and dryer to get to my office. I often wonder what they must have been thinking.

The past 30 years have taken AFTH places I never imagined when I founded it. I'm humbled to say that AFTH has had the privilege of placing 6,555 children into forever homes and we concluded 2015 with 145 domestic placements, 50% of which were emergency placements.

AFTH has built an extensive network through outreach and education with organizations that provide services to expecting parents. Our goal is for women considering adoption to do so armed with information about the process, their rights and the services AFTH can provide whether or not they ultimately place their child. Women have said over and over that they choose AFTH because they know we are here to help, not to pressure.

AFTH not only provides free services to expecting parents, but goes a step further to provide necessary financial assistance as well. During counseling, social workers see areas of great need such as food, clothing, housing that are not being met. AFTH events and fundraisers such as the Find Her Footing 5K, Paper Heart Project and the AFTH Calendar are intended to garner donations for the Birthparent Fund and the Birthparent Scholarship Fund.

In December, AFTH donated over \$15,000 in gift cards to birthparents with children who were struggling for the holidays (front page). I'm so grateful for the level of community support we had this year for the 5K, Paper Heart Project (page 4), event sponsors and donors and individuals who hosted fundraisiers like the From the Heart Cabaret Benefit (page 11). Over the course of the past year, AFTH's marketing team has raised over \$30,000 in donations, every dollar of which will go toward making a better tomorrow for men and women in need.

The Birthparent Scholarship Fund was established in late 2014 and in January of 2015 AFTH awarded the first two scholarships to deserving applicants. Since then, six additional scholarships have been awarded (page 6).

In October, AFTH held the Building Beautiful Futures event at the Racquet Club of Philadelphia in center city. I was honored to see how many people came out in celebration of AFTH's 30 year milestone. It was a fabulous time with great casino entertainment not to mention the food and music as well as the celebrity host of the night Cory Wade.

In order to fully embrace open adoption, our policy was revised to require all prospective adoptive parents to be open to a minimum of one visit a year. Additionally, we believe families need to honor their commitment to openness whether or not future contact agreements are legally binding. We are continuing to develop our education programs to better equip parents raising children who are of a different race. After careful deliberation, AFTH no longer allows families the option of only being open to biracial children.

We have had quite a few prospective adoptive parents switch to our agency after beginning their adoption journey with a facilitator or matching service due their inability to offer a full range of necessary services.

Despite being unable to offer an accurate average wait time due to the number of variables involved, we can say that as of December, the overwhelming majority (81%) are waiting less than 18 months, 66% waiting less than 1 year and 37% are waiting 6 months or less. Families open to African American children are seeing shorter wait times with 81% waiting less than 1 year and almost half only waiting 6 months or less.

Congrats to all the new families created in 2015 and a warm welcome to those who have just begun their journey.

International Adoption News

AFTH prides itself on keeping abreast of news regarding inter-country adoption. Despite no longer having international programs, the agency is able to work as a supervised provider to offer international Home Studies, Education, Post-Adoption/Placement Reports and Services, and other

assistance in support of international adoptions. AFTH collaborates with many agencies across the United States that do provide inter-country adoption placement services. China:

There is little to report on this front. The CCCWA is currently assigning referrals to families with a Log in Date up to 1/6/07. Last June they were at the end of December 2006 with assignment log in dates. This goes to show how slowly they are moving. Our lives can change so radically over a nine year period that it is hard to imagine still waiting to adopt after all that time. There are three former AFTH families, who transferred to Carolina Adoption Services, with a LID of 1/16/07. It remains to be seen if any wish to move forward.

China's One Child Policy Has Ended:

As many of you already know it was announced in late October, China's One Child Policy has come to an end and couples will now be allowed to have two children. The one child policy was instituted in 1980 and adoption of their unwanted girls, as boys are traditionally favored, became popular in the nineties. The effects of the policy have left the Chinese with a rapidly aging population and potential labor shortages plus a lack of available women for the upcoming male segment of Chinese society.

Chinese Consul Thanks US Families for Adopting Children From China:

In December the Chinese Consul in San Francisco held a reception for 29 American families who adopted Chinese children and live in the Bay Area. He thanked the American parents for their "enduring love and selfless devotion to the Chinese children, bringing them up with warmth and happiness." He told the children "China, your country of birth, will never forget you and will always miss and welcome you. This means you belong to two families."

Colombia:

In a historic decision, Colombia's constitutional court opened the door in November for same sex couples to legally adopt children in the conservative South American nation. With this decision Colombia becomes one of a handful of South American countries, including Argentina and Uruguay, in allowing same sex couples to adopt.

India:

On October 21, 2015 the Indian government informed the U.S. Embassy in New Delhi that adoptive parents must possess an exit permit issued by the Foreigners Regional Registration Office (FRRO) in New Delhi before departing India with their adopted or prospective adoptive child. FRRO can be emailed at frrodli. support@nic or frrodli.support@gov.in.

Namibia:

The Hague Adoption Convention Entered into force in Namibia on January 1, 2016. U.S. prospective adoptive parents who may be interested in this country should check adoption@state.gov for updated information on the United States' determination.

Uganda:

As of 12/31/15, the U.S. Department of State has received information from prospective adoptive families currently in Uganda regarding reports that Ugandan government officials have visited prospective adoptive families and asked to review their dossiers. The Department is gathering more information about these reports and will post an update on their website as more information becomes available.

A portion of sales went toward the fund and between the two events with over 75 shoppers, a little more than \$400 was raised!

Our Allentown Office was honored when Andrea, one of their adoptive mothers, contacted them about hosting a benefit cabaret to raise money for the Birthmother Fund. She works in theater and each year in November the Allentown BrewWorks chooses



an organization as a beneficiary of the benefit show. AFTH was thrilled to be and the Allentown staff couldn't wait to attend. Karen Friedman, AFTH Office Manager said "last night's cabaret was really awesome. It was so honest and heartfelt and I felt lifted up working for AFTH. All of the talented singers had an adoption story to share and all the songs were geared towards love and childhood in between personal shared stories. Really cool!" With 50% of the tickets sales for their November 12th show being donated, it brought in \$250 for the Birthmother Fund!
